Floor covering is not required for booths in the Outdoor Adventure area.

Acceptance into this area is subject to approval by Show Management.

Spring Time Market Place

This area is like a "Farmers Market" that provides opportunities for small businesses to sell their products. Some examples of the products include: Artwork, Candles, Fabric Accessories, Jewelry, Personal Care Products, Plants, Take Home Food & Treats, Woodworking.

Acceptance into this area is subject to approval by Show Management.

Floor covering for booths in the Spring Time Market Place will not be required.

Booth Rental:

- Rental includes: 8' back drape, 3' side drapes and electrical.
- You will only be allowed to display/sell the products/services that you have listed on your application form and that appear on your exhibitor contract. If you wish to add a product/service that will be displayed in your space, you must submit a written request to Show Management.

Subletting Space:

Subletting is prohibited. No exhibitor shall assign, sublet or apportion the whole or any part of the space allotted, or have representatives, materials, or equipment from other than its own company.

Booth Expectations:

- Booth must be staffed during all show hours;
- Early teardown is prohibited;
- Displays must comply with fire regulations;
- Exhibitors must provide their own floor covering, lighting, tables/chairs and signage. **Booth flooring is required for all exhibit space unless otherwise noted.** Each Exhibitor is required to have appropriate flooring covering their complete booth. Flooring must NOT exceed the booth area.
- Volume levels must not interfere with neighbouring exhibitors;
- Demonstrations must remain within booth boundaries;
- Aisles must remain unobstructed;
- Signage or display materials must be contained within the boundaries of your rented space;
- No handwritten or unprofessional signage;
